**3.** Conditional Use Application: Medical Marijuana Production Facility. Paper Birch Property LLC. (R70-12-1) 357 Portland Street.

Geoff Aleva stated that this is the first Medical Marijuana Facility that has gone in front of the Berwick Planning Board and also noted it is not the first Marijuana Facility in Berwick. The building construction will be phased.

Mr. Aleva stated the odor control plan has a maintenance plan, and provides the Code Enforcement Officer an avenue to address odor concerns.

Susan Morse of Jordan Street asked how many plants are expected to be growing at the facility. Ms. Morse said her concern is the size of the facility.
