## **Public Hearing**

**2.** Continued Public Hearing. Conditional Use Application. Parking Facility. 71 Sullivan Street (U3-11) CI Zone. Town of Berwick.

Luisa Sheldon of 65 Sullivan Street introduced herself as an abutter. Ms. Sheldon handed the Board materials and said that the images show that the project should fall under Site Plan Review.

Shawn Goodwin asked if the new Code Enforcement Officer would follow the Planning Board's wishes of having the parking lot shut down.

## **Old Business**

**2.** Conditional Use Application. Parking Facility. 71 Sullivan Street (U3-11) CI Zone. Town of Berwick.

Lee Jay Feldman said Milone & MacBroom submitted their 3<sup>rd</sup> party review.

Nichole Fecteau said the Board requested the conditions of the site before demolition.

Todd Gammon introduced himself and summarized the storm water improvements. Ms. Fecteau asked to see a walking path delineated for safe access through to Memorial Field. Dave Andreesen asked about keeping cars from parking on the grass. Mr. Gammon said the plan is to have a well-defined edge and that there will be more spaces available so there would be less motivation to park on the grass. Sean Winston said granite would be necessary to prevent people from parking on the grass.

Tom Wright said people will be walking through the parking lot and would be tough to prevent and that there are grass strips on either side of the lot that could be used for walking and the Town could put up signs.

Jenifer McCabe, Town Code Enforcement Officer, said the lot was kept open due to life safety concerns. Ms. McCabe said emergency vehicles could not get access into Memorial Field if there was an emergency. Nichole Fecteau asked what repercussions would there be for a regular applicant. Ms. McCabe said what the previous CEO did was hold off on action if they were actively going through the Planning Board process.

Tom Wright said the fence was put up to protect the abutters. Mr. Wright said the Town's Attorney said the Town has the right to use the parking lot. Nichole Fecteau requested that the statement from the Town attorney be put into the file.

Dave Andreesen read a letter sent from Frank Underwood.

Nichole Fecteau said she is not confidence the project does not require Site Plan Review. Lee Jay Feldman read through the standards in the Berwick Land Use Ordinance and determined that the application does not need Site Plan Review.

Lee Jay Feldman brought up the condition of no snow dumping.

Sean Winston asked for a condition of parking delineation to prevent parking on grass.

The Town will not be plowing the lot in the winter time and the lot will not be used as a park and ride. Overnight parking will not be allowed.
